# **General Details / Operating Condition:**

Authorisation is given to QUBE to occupy the Boambee Beach Loop Line from 0230 hours Saturday 23<sup>rd</sup> August 2025 until 2345 hours Sunday 24<sup>th</sup> August 2025, to permit stabling of QUBE train 6BW7 and to be left unattended.

# **Safeworking Arrangements:**

The train is permitted to be left unattended in accordance with the following instructions:

#### Before the Rail Traffic Crew departs, they must ensure the following:

- Both 51 and 52 points have been returned to the normal position, and after authority has been obtained by the Network Controller, secure using point clips and SL locks, and
- That 100% of handbrakes are applied on the locomotive/s and wagons.

# The Network Controller must receive assurances from the Rail Traffic Crew that:

- Both 51 and 52 points have been secured in the normal position using point clips and SL locks,
  and
- That 100% of handbrakes have been applies to the locomotive/s and wagons.

# The Network Controller must ensure that:

- Blocking facilities have been applied to prevent the operation of 51 and 52 points, and
- An appropriate entry has been shown on the Train Control Graph detailing the Train has been stabled on the Loop Line, and
- The entry is carried over onto the subsequent Train Control Graphs until Train 1NW7 departs.

#### Preparation of Train 1NW7 in readiness for departure.

• Until authority is given by the Network Controller, the Rail Traffic Crew must not remove the point clips and SL locks from 51 and 52 points at Boambee Beach.
