General Details / Operating Condition:

Commencing at 0630 hours Tuesday 23rd September 2025 until 0630 hours Friday 26th September 2025, or until the works are completed, the following infrastructure upgrading works will be undertaken at Aberdeen:

- Book out of use and permanently remove the existing 51 points machines and associated equipment, including the Emergency Switch Machine Locks (ESML), and
- Install, commission and book into use for the 51 points, a new M23A MKIII Switch Machine and associated equipment, including an Emergency Operating Lock (EOL).

and

- Permanently remove the Traffic Hut for 51 Points, which housed the ESML, and
- Install the new EOL on the side wall of the existing 51 location.

The commissioning of these new arrangements and alterations will involve route-setting activities, signal testing, track circuit testing, and point testing.

Safeworking Arrangements:

All work must be carried out as per the appropriate ARTC Network Rules and Procedures.

As required an Infrastructure Booking Advice (ANRF 003) must be compiled as per ARTC NSW Rules & Procedures ANWT 312 Infrastructure Booking Advice and ANPR 704 Using Infrastructure Booking Advice.
